- Background: This RFP is for engaging services for handling/packing and transportation of household goods from Yerevan [Armenia] to Moscow (Russia) by Air on door-to-door basis. The proposals for handling/packing and transportation by Air are invited as per details in the following paras. These household goods belong to a Diplomatic Officer in the Embassy of India, Yerevan.
- 2. Scope of work: The following would be the scope of work: "
- (i). Handling/packing and transportation by Air from Yerevan [Armenia] to Moscow [Russia]
- (ii). Custom clearance/terminal handling charges and other formalities at Yerevan and Moscow, and delivery, unpacking and removal of debris at the residence in Moscow.

#### 3. Inviting bids from companies:

Household goods (maximum 1020 kgs) will be transported by Air frem Yerevan (Armenia) to Moscow (Russia) on door-to-door basis. Packing materials and other related services should be of international standards. The quotations with detailed break up, including price per kg, are invited in scaled cover envelope with the element of insurance premium in percentage. Offer should be in US\$ only and should include all charges. Payment will be made through bank transfer or cheque only. No eash payment will be made. Quotation should remain valid for 60 days and the bidding should be in the following two parts:
